Presidents Report – Roger Walker

Water and Sewer Report – Al Rennert

New pumps where being installed at the sewer plant. The new meters will be arriving in 2 weeks and will be installed at the board members' homes first so that we can test them and make sure they are working correctly before proceeding to install in the rest of the Village.

Park and Special Projects - Brenda Wood

Wood presented a note that will be in the next Community Newsletter regarding limbs or small twigs being picked up by village works as well as letting telling about a location at the sewer plant that they can take limbs to. Rennert noted that the new benches are very nice and a new addition to downtown.

Police – Pam Anklam

Anklam turned her report over to Chief Swisher. Swisher presented a quote from QNS for 2 refurbished laptops for the police department at the cost of \$2,808.72. These are Toughbook laptops for the police cars. Their current Toughbook has windows 7 and for security purposes need to be updated.
