# Presidents Report – Roger Walker absent – Dennis Garmon reported

- 1. Sidewalks are getting done Clem reported that we got an excellent price from Brad Eaton. They also added a section in front of High street that the resident will pay for ½ of the total project in front of her house.
- 2. The house that burnt down on State street, if the Village would clean it up, we could put a lien on property.
- 3. The storm sewer drain by the curve on Rt. 32 has roots in the tile so that it doesn't flow anymore. Walker is working with several people in the area to help get it repaired. The plan is to dig up the roots from the trees and hopefully get the tile replaced. Clem doesn't think it will cost too much to fix it.
- 4. Anklam thinks that the street behind bank really needs to be fixed better than it is.
- 5. Walker is working with the people on the Railroad property and also rethinking about the drainage problem. They are discussing taking a drain north by the road east of the grain elevator to the Railroad property and go West down the Railroad property to connect up with the current drain.
