Department Reports Presidents Report – Roger Walker

Bills are being paid for the Water Improvement Project.

The tree guy has not come to cut the trees as of yet, he has been tied up in another town. The Police department – wants us to look at our comp time ordinance. Chief Swisher has provided a copy from another town. Walker will give it to the new police trustee. Walker appointed Garmon as the new police trustee. And Garmon has agreed to do it.

Water and Sewer Report – AI Rennert

Reported – power washed the water tower and the dentation tank was cleaned. Capped the old water main and we are now on the new system. Will do water flushing of the hydrants next week. Need a new hydrant at the park. The dehumidifier needs to be fixed. All meters are installed. They are going to get a bid to install a wall inside the water department. Also, the door needs to be replaced; vented the chemical containers.

Park and Special Projects -

Walker reported that the new airplane that was just installed has been torn up. They are going to remove it and not install anything more until we can install a security system in the park.

Police -

Already reported on the two items the breathalyzer and the comp time review. The brakes and rotors need to be replaced on the older police car. Employee Chris Gillis has volunteered to do that.

Buildings and Grounds – Dennis Garmon

Garmon reported that he called Ameren about the street light on high street that was out. Walker said there was a total of 10 street lights that are out.

Garmon has spoken to Dee Frantz, of Shawnee Communications about them putting free wireless access in the park for those students that don't have Internet at home and they can come to the park to use the wireless. He suggested that they have some way to turn off and on the service; also, to restrict the websites that they can go to. Shawnee will be having another meeting this week and will discuss it. He also, asked it there could be a hot spot downtown that we can have cameras there as well. He will report back next month.
