#### **Department Reports**

#### Water and Sewer Report – Todd Hale

Hale reported the things that have been done at the water plant. Tree roots were in the line behind the bank. Asked if we wanted to purchase the old ambulance for job sites as discussed. It was decided not to purchase it. Hale will also go to Kates in Arthur to see what they have. The split air conditioning and heating unit for the water plant was discussed. We already approved to purchase it we just need to get more estimates. Hale asked about the dog ordinance. There are a lot of dogs that are running lose. Walker said if people have a complaint than they need to come in and file a complaint. Fair is to contact Frank from the Illinois Codification Service regarding junk vehicles. Clough also brought up that several of the lawns are not being mowed this year.

#### Park and Special Projects – Brittany Bates

Bates reported on the items that she has purchased for the park. Some of the parents have expressed concerns about the kiddy park not having a fence around it. They also need a bench in that area as well as shade. It was suggested that the kiddy park be moved to another area where there is shade; or plant some trees around the area. Movie in the park will be June 24<sup>th</sup> a movie and concession. If they take in money from the concession stand Fair would need to create an account for that money. The community garden was planted today.

#### Police - Dennis Garmon

Garmon went over the Police Department report from Chief Swisher. There have been several breakins in Lovington. They are making some progress.

# Streets and Alleys – Curt Clough

Clough – Chris Gillis gave him an update on the alley's that he has been working on. The alleys that are completed are looking very good.

# **Buildings and Grounds – April Daily**

Daily reported that Gillis got a new sprayer to spray weeds. She hopes that the garage door on the storage building will be done by the end of the month. She spoke to someone at Bethany regarding a subscription for the Police handbook ordinance – Garmon will talk to Swisher regarding it.

# **Insurance – Mike Young absent**

Walker reported that the insurance company provided us with a letter saying that they can't cover us regarding the lawsuit.

# **Presidents Report – Roger Walker**

Regarding fire security company - Walker will contact IMLRMA and we need to put this on the agenda for June.

We have a quote for putting guttering at the park pavilion.
