The attorney says that this can't be done. The ordinance was pulled up and it was decided to increase the per day fee as well as the yearly fee. Stanberry will send the requested increase to the attorney to prepare an increase to the ordinance that will be prepared for next month's meeting.

Stanberry also reported that he and Chief Swisher are revising the requirements from the ordinance to the requirements that the Chief has for new solicitors. Our current ordinance does not prohibit clubs (school or church) from soliciting.
